### Update frequency:

Daily (EOD broker file)

### Methodology:

EOD broker prices are based on expert assessment of daily activity in covered markets. Displayed prices do not represent currently actionable orders.

### Curve coverage:

Curve coverage is dependent on market activity and may fluctuate based on changes in liquidity. Curves typically span 1-9 calendar years or 4-5 halves.
